

# Big solutions from big data

Our Department of Computer and Information Sciences is addressing global challenges in governments, businesses and industries by exploring the way data and information is created, used and managed in order to save time, money and resource.

Dr Akhtar Ali has developed a holistic data analytical model which reduces workload on doctors in NHS General Practices. His research explores the information source as big data through machine learning and analytics, which has resulted in significant outcomes for the commissioning and delivery of primary care.

# Co-creating new knowledge

Dr Longzhi Yang is part of a research group that develops various tools and techniques for modelling, analysing, mining, and visualising data.

His cyber security research proposes a framework of big data governance that guides organisations to make better data-informed business decisions within the related regularity framework, with close attention paid to data security, privacy and accessibility.

At Northumbria, our research-led teaching is directly related to a number of our computer science courses and Dr Yang has involved multiple students in industry-funded research which has improved their employability prospects or helped advance their academic careers.

# Learning at the cutting edge

Jackie Harvey and Peter Sproat are among the UK's leading academic experts on money laundering, and as part of MSc Forensic Accounting have designed a module based on their ongoing research.

'Financial Crime: Law and Regulation' constantly evolves as Professor Harvey and Dr Sproat further their research, and engage with practitioners including the Law Commission.

Students approach the module's subject matter through a critical lens. They learn about the complex web of legislation and regulations surrounding financial crime – as they would at other universities – but they also learn to question its complexity. Is there a better way to prevent financial misconduct on a global scale? As a result of their research-rich learning experience at Northumbria, our graduates may be the ones to develop alternative approaches.

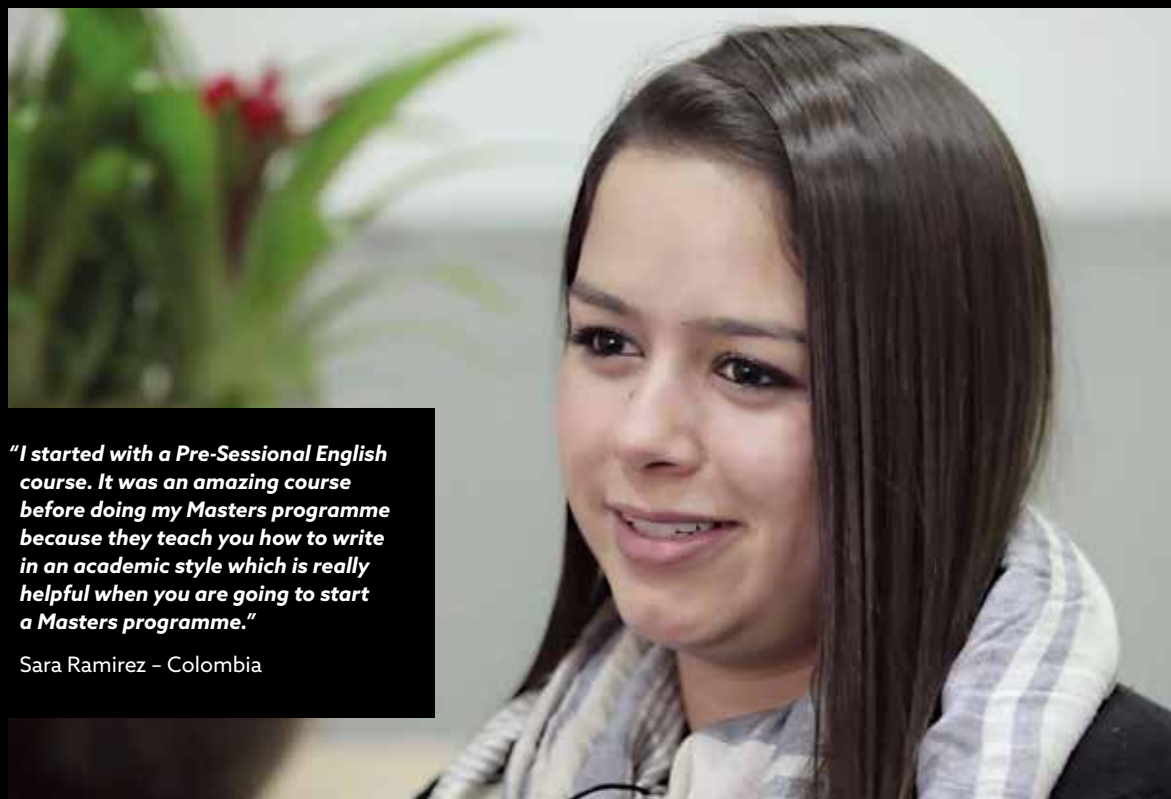

**Our Pre-Sessional English programme is designed to build your English language abilities ready for undergraduate or postgraduate study.**












You will develop academic English skills in a content-based approach to learning involving critical thinking, questioning, discussion, reflection and analysis. You will also develop the ideas and concepts necessary to participate in the global academic community.

- Improve your academic study skills, as well as your reading, writing, listening and speaking skills
- Introduce yourself to life in the UK and British culture
- Develop your understanding of university systems, services and facilities

This full-time programme is ideal if your academic qualifications meet the requirements for your chosen undergraduate or postgraduate course, but your English language level falls below the entry requirements of the academic course you wish to join. The programme teaches you the language and other academic skills necessary for you to gain the maximum benefit from your future academic course.

## How will I be taught and assessed?

A particular emphasis is placed on reading and writing academic English and you will be supported in producing extended writing as part of your assessment. You will develop these skills in a content-based approach to learning involving critical thinking, questioning, discussion, reflection and analysis. You will also develop the ideas and concepts necessary to participate in the global academic community.

You will also be assigned your own Guidance Tutor who will provide academic and pastoral support and be your first point of contact if you have questions or problems.

## Careers and further study

Progression on to your chosen academic course depends on a mix of continuous assessment and an end-of-semester examinations (not IELTS).

- Listening and Speaking
- Reading Skills
- Writing Skills
- Researching Life in Britain
- Social English

# Top-Up degrees

There are lots of different routes in to higher education, each depending on the qualifications you hold, and at which level.

If you currently hold an HND, Foundation Degree or equivalent Level 5 qualification, you may be able to join one of our Top-Up degrees. These programmes are the final year of an undergraduate degree. They will build upon your knowledge and skills from your previous qualification and are a very popular choice amongst students looking to progress and achieve an undergraduate degree with just one year of study.



This course will allow you to top up your existing qualifications to an honours degree in one year, while benefiting from all that Northumbria University has to offer. You'll build on your all-round knowledge of business, adding expertise in accounting and finance as well as transferable professional and managerial techniques.

The BA (Hons) Accounting and Finance (Top-Up) course includes specialist modules that cover financial reporting analysis, strategic management accounting, and international financial management. Additionally, this course provides an excellent foundation for jobs in finance, banking, government, and general business leadership.

### How will I be taught and assessed?

You will be taught through a combination of lectures and seminars, though for the more technical aspects you will also attend computer-based workshops. You will also be expected to engage in independent study involving directed and self-directed learning. Assessments on this course take place through coursework only.

### Careers and further study

At the end of this course, you could follow previous graduates into accounting and finance roles, including training contracts with leading accounting practices. Equally, you could move into a range of careers in business and management, both in the UK and around the world.











Completion of the Academic and Career Development module, will result in your own independently prepared career plan, including preparation of key employment documents such as application forms, cover letters and CVs.

# Advanced Practice

One of the degree types we offer at Northumbria is the ‘Masters with Advanced Practice’. You might not have heard of this kind of course before, so here we explain what it means, who it might suit and why we think it is such a good way to learn.

### Putting theory into practice

The Advanced Practice element of the programme allows you to extend your studies to include either an Internship (may be paid or unpaid), a Group Consultancy Project or a research project, enabling you to work on a business problem, developing valuable work experience and business insight.


### Fast-track your career

The programmes offer you an opportunity to stand out in interviews, allowing you to recall real examples of skills learnt when applying for future jobs. Whether it is attending meetings, gathering market research or analysing recent figures – contributing to an organisation and communicating with staff will give you experience beyond the classroom.

### Course structure

The Advanced Practice stage of the programme commences in your penultimate semester. If you start your programme in September, this will be after a summer break. You will work closely with our internship support team who will help you secure an internship of between 12 and 15 weeks. This will be equivalent to a full-time position.

## Fund your future

The UK Government offers a postgraduate loan of up to £10,000+ to full-time and part-time UK and EU students starting a full, standalone Masters. This loan can be used to help fund your course fees and your living costs. Here's some useful information on how you can fund your future.



### How much can you get?

UK and EU students starting courses from August 2018\* onwards are now able to apply for a £10,000+ postgraduate loan through the UK government website.

The loan can be used to pay your course fees and help with living expenses. You also have the ability to choose how much you wish to borrow – this can be any amount between £1 and the maximum £10,000+. Unlike undergraduate tuition loans, the funds are paid directly to you, not your university.

### Who can apply?

The eligibility criteria for the postgraduate loan states, you must be a resident of the UK or EU. If you live in the UK, you can get the loan if all of the following apply to you:

- You're a UK national or have settled status
- You normally reside in England
- You've been living in the UK, Channel Islands or Isle of Man for 3 years prior to your course's start date

If you're an EU national, you may be eligible if:

- You've lived in the EEA or Switzerland for the past three years, and
- You'll be living in the UK on the first day of your course

This loan is aimed at students who do not hold a qualification at Masters level. If you already hold a postgraduate degree, you will not be eligible for funding.

Both UK and European Union (EU) students follow exactly the same application process outlined below. Once you have selected a course, you need to ensure that you have, or are working towards, the appropriate entry qualifications.

### Undergraduate courses

UK and EU students wishing to apply to an undergraduate programme at Northumbria University London should apply via UCAS at: [ucas.com](https://ucas.com).

The UCAS institution code for Northumbria University is NORTH N77.

You may apply for up to five courses and your choices should be listed in alphabetical order. All applications are treated equally and admissions selectors will not be able to see which other institutions you have applied to, so you should not express any order of preference when you apply.

### Postgraduate courses

Applications for all courses should be made direct to the University via our online application form. Simply click on the 'Apply Online' button you will see on each of our course pages: [northumbria.ac.uk/london-pg](https://northumbria.ac.uk/london-pg). This will submit an application directly to Northumbria Admissions department.

Whilst most of our courses do not set an exact deadline for applications, you are advised to apply early to secure your place and organise any student funding.

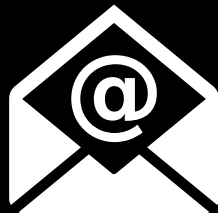

### What happens next?

Once we receive your fully completed application form and supporting documents, you should receive our decision within a few weeks by email, this will include any outstanding conditions that you will need to meet to satisfy the requirements for your unconditional offer.



# 4

### Accepting your offer

To accept your offer you should complete and return an Offer Acceptance Form, and, unless your fees are being paid by a recognised financial sponsor, you will also need to pay a deposit and send us your Deposit Payment Form. Applicants who pay their deposit in full before advertised deadlines may also be entitled to an Early Payment Discount. Information regarding these discounts will be detailed in the offer email that we send you but you can also find out more, including Terms and Conditions, by visiting **northumbria.ac.uk/london-terms**

If your offer is conditional, please send us evidence that you have met the conditions of your offer as soon as possible so that we can confirm your place on your course.



# 5

### Applying for a Visa

If you are coming to study a full-time course in the UK, it may be necessary for you to obtain a Tier 4 (General) Student visa. You can find out more about this at **ukvisas.gov.uk**



In order to apply for a Tier 4 visa, you will need a Confirmation of Acceptance for Studies (CAS), which you can request on your Offer Acceptance Form once you have satisfied all conditions and paid any necessary deposit. We will email your CAS letter to the email address you have supplied on your application form. Please note, in order for you to receive your CAS in time for your visa application and the start of your course, you will need to send your offer acceptance and CAS request to us by the advertised deadlines on our website.

If you require a Tier 4 visa for studying on your new course, you must inform us of any previous Tier 4 (General) Student visas that you have held. If you are currently in the UK, you will also be required to provide a copy of your current visa. This is so we can establish whether we need to confirm on your CAS that your new course represents academic progression or complements previous studies. It will also allow us to check that you have enough time left under Tier 4 in order to complete your new course.

# 6

### Deadlines

We strongly recommend that you apply as early as possible to allow enough time to complete all the preparations you need to make in order to study in the UK. After receiving an offer it can take several months to arrange your finances and apply for a visa and it is important that you arrive in good time for our international enrolment session.

## Financial support for UK/EU students

### Undergraduate Tuition Fee Loans

Tuition fee loans pay for your course and all UK/EU undergraduate students are eligible for a loan to cover the cost of these fees, regardless of your household income. Here are a few facts about how the loans work:

- The money is paid directly to the University by Student Finance England (SFE) so you don't have to worry about it.
- Tuition fee loans incur interest at RPI + 3%.
- You don't have to start paying back the loan until the April after you graduate and are earning over £25,000 at this time. This means that if you begin an undergraduate completion award (Top-Up) with us in September 2020, your first payment won't be until April 2022 and only if you are earning £25,000 a year or more. Any earnings over this amount will see a 9% deduction as repayment towards your student loan.\*

### Government Loan for Postgraduate study

UK and EU students are now able to apply for a £10,000+ postgraduate loan. The loan can be used to pay your course fees and help with living expenses.

If your course lasts more than a year – for example if you're a part-time Masters student studying over two years, you can take up to £5,000 in the first year and the rest in your second year.

The repayment amount will be 6% of income above the threshold of £21,000. If you were a UK undergraduate, this is on top of the 9% you pay back on your undergraduate loan, although only on the annual income you earn over £21,000.

### Instalment plan

For self-financing students studying our part-time postgraduate programmes, we are happy to offer an interest-free payment plan, allowing you to spread the cost of your course over 24 months. The first payment is due on or shortly before enrolment, with subsequent payments falling due on the first working day of each month thereafter.

Please note that instalment plans are not available to students receiving postgraduate loans.

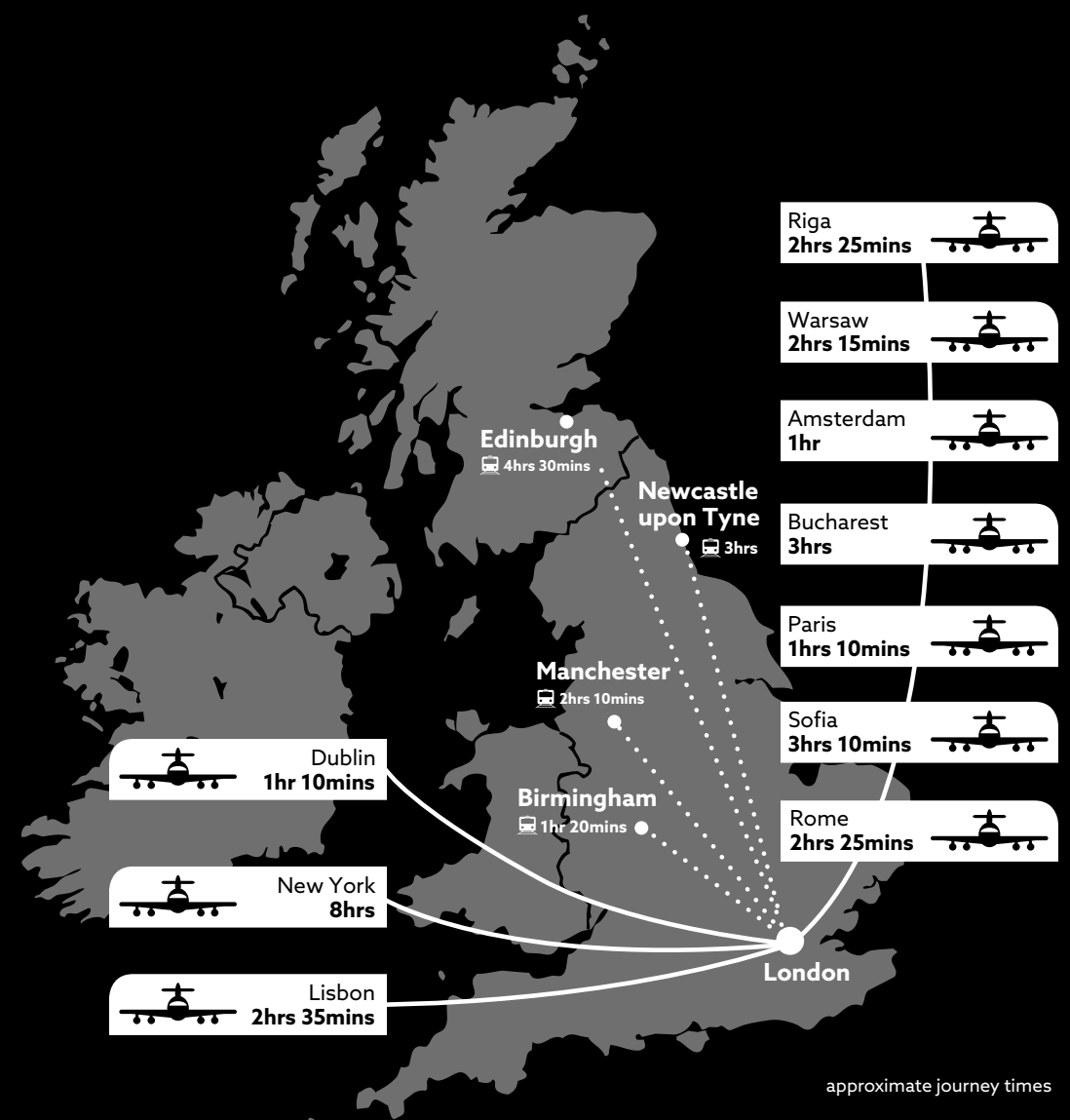
